You “vacate The Default Judgment”, That Is, Until You Have The Judgment Removed Or Erased. To Vacate A Default Judgment, Do The Following: 1. Get The Form Called Notice Of Motion To Vacate Judgment From The Small Claims Clerk. 2. Fill The Form Out And File It With The Small Claims Clerk With A Filing Fee. You Must Do This Within 30 Days Of ... May 1th, 2024

(4) Motion By Respondent - The Respondent May Move To Vacate The Order Of Default Within Thirty (30) Days After Its Entry. (5) Disposition Of Motion - If The Hearing Panel Finds That There Is A Substantial And Apr 1th, 2024
