SUMMARY: THE MOBILE HOME PARKS RESIDENTIAL LANDLORD AND ...

The Act Does Not Apply To Recreational Vehicles (which Includes Park Models) Or If Mobile Home And Space Are Owned By The Same Person. A.R.S. § 33-1407(B). Note: See Changes To Relocation Fund Related To Park Models. The Act Only Applies To The Rental Of A Space In A Mobile Home Park; A Mobile Home Park Is May 2th, 2024

- Give You A Fit Place To Live. This Means The Floor Can Be Rotten, The Roof Can Leak, And The Plumbing Does Not Work.
- Make Any Repairs To The Home Or Common Areas. Even If Your Landlord Tells You That Repairs Will Be Made, That Agreement Cannot Be Enforced. If The Landlord Makes A Repair, Though, The Landlord Must Do It Correctly. Feb 3th, 2024
